MINUTES OF THE ANNUAL MEETING OF THE WYOMING STATE BAR

September 2, 3, 4, 1965 Casper, Wyoming

The 25th Annual Meeting of the Integrated Bar, the same being also the 50th Annual Meeting of the Wyoming State Bar, was called to order by President R. R. Bostwick, at 9:30 o'clock A.M. in the Spruce Room of the beautiful new Student Union, Casper Community College, Casper, Wyoming. President Bostwick opened the session by calling upon R. R. Rose, Casper, Wyoming, President of the Natrona County Bar, who cordially welcomed the members of the Wyoming State Bar to Casper for the annual convention. Responding to Mr. Rose's remarks, was Dr. Tim Aley, President of the Casper Community College, who also cordially welcomed the members of the Wyoming State Bar, advising those in attendance that the Wyoming State Bar was privileged to become the first group to hold a meeting in the Student Union.

After thanking both Mr. Rose and President Aley, President Bostwick introduced Cullen Y. Christensen, Salt Lake City, Utah, President-elect of the Utah State Bar, following which, the President called upon Vice-president George F. Guy, Cheyenne, Wyoming, to preside over the meeting.

Vice-president Guy in turn introduced President R. R. Bostwick who gave the President's annual report, during which President Bostwick introduced Edward W. Kuhn, Memphis, Tennessee, the 1965-66 President of the American Bar Association.

Following his report, President Bostwick once again presided over the meeting, and the first attendance drawing for the day was held with Robert B. Ranck, Jackson, Wyoming, winning Trial Handbook, donated by Prentice-Hall, Inc.

President Bostwick then recessed the meeting at 10:15 A.M. for a coffee break, following which a congratulatory telegram was read from the Honorable Milward L. Simpson, U.S. Senator from Wyoming, advising the membership that due to his present duties in Washington, he would be unable to attend the convention. Senator Simpson wished the Wyoming State Bar a fruitful and successful meeting.

President Bostwick then introduced the Honorable Rodney M. Guthrie, presiding Judge, Dr. Robert Horstman, M.D., witness, Houston Williams, Gene Lonabaugh, Walter Phelan, and William H. Brown, examining attorneys, who conducted a trial vignette entitled "How Badly Is He Hurt?" for the remainder of the morning.

After thanking the participating members of the trial vignette, President Bostwick recessed the meeting at 12:00 o'clock noon, until 9:00 o'clock A.M., Friday, September 3, 1965.

The lawyers joined their wives for luncheon at the Holiday Inn during which Edward W. Kuhn, President of American Bar Association, addressed the gathering. Mr. Kuhn's remarks depicted the practice of law as it had been in the past, stressing the need for change in the future.

Following the noon luncheon, golf tournaments for both men and women were held at the Casper Country Club, with boating on Alcova Lake and excursions to Casper Mountain, Fort Caspar, and the Casper City parks providing entertainment for those not joining in the golf tournament.

The 50th Annual Meeting of the Wyoming State Bar reconvened on September 3, 1965, in the Spruce Room of the Student Union of the Casper Community College at 9:30 o'clock A.M., by Vice-president George F. Guy, Cheyenne, Wyoming, who presided over the morning session. Mr. Guy introduced the American Judicature Society panel who presented "Modern Courts for Wyoming" with Chief Justice Edward E. Pringle, Supreme Court of Colorado, speaking on "Court Organization and Administration;" Allen Levinthal, Assistant Director of American Judicature Society, Chicago, Illinois, presenting the topic "Courts of Limited and Special Jurisdiction" and Bob Allard, Director of Special Projects, American Judicature Society, Chicago, Illinois, talking to the membership on recent "Court Modernization Accomplishments."

After Mr. Allard's talk, a fifteen minute coffee break was called at 10:15, following which Robert A. Schroeder, President-elect of the Missouri State Bar Association, discussed the subject, "The Trial Lawyer Looks At Merit Judicial Selection." At the conclusion of Mr. Schroeder's talk, the balance of the morning was spent in a question and answer session with the membership at large participating. Included in the morning session were committee reports by R. S. Lowe, Rawlins, Wyoming, Chairman of the Minor Courts Committee, and W. Hume Everett, Casper, Wyoming, Chairman of the Judicial Committee.

John F. Sullivan, Laramie, Wyoming, was awarded a one year subscription to Shepard's Wyoming Citation, donated by Shepard's

Citations. Following the presentation of the door prize, Vice-president Guy recessed the meeting until 2:30 P.M., Friday, September 3, 1965.

The members met their wives for luncheon in the Spruce Room of the Student Union of Casper Community College. President-elect Elmer J. Scott, Worland, Wyoming, presided over the luncheon, presenting Glenn R. Winters, Executive Director, American Judicature Society, Chicago, Illinois, who spoke to the assemblage on "What Judicial Reform Can Do For You."

President R. R. Bostwick reconvened the meeting at 2:30 P.M., in the Spruce Room holding two attendance drawings. A. M. Pence, Laramie, Wyoming, was the lucky recipient of the Uniform Laws Annotated, donated by West Publishing Company. Chet Ingle, Thermopolis, was awarded Jones On Evidence, donated by Bancroft-Whitney.

Following the attendance drawindg, President Bostwick introduced John D. Fey, President of the University of Wyoming, who favored the gathering with a few remarks concerning higher education.

President Bostwick next called on Edward E. Murane for his annual report on the activities of the House of Delegates of the American Bar Association. Mr. Murane reported on those activities as Chairman of that group.

Following Mr. Murane's report, Mr. Bostwick called on A. M. Pence, Laramie, Wyoming, representative of the Wyoming State Bar to the House of Delegates of the American Bar Association. Mr. Pence also reported on the activities for the National Conference On Uniform Laws, and the Annual American Bar Association meeting held in Miami, August, 1965.

After thanking both Mr. Murane and Mr. Pence for their reports, President Bostwick called on Leonard Lang, Committee member of the Necrology Committe, who reported for that Committee in the absence of John O'Callahan, Basin, Wyoming, who was unable to attend. At the conclusion of the Necrology report, the entire membership stood for a moment of silence in the memory of the departed members.

Following the Necrology report, President Bostwick called on Vice-president George Guy to introduce the new members of the Wyoming State Bar in attendance at the Annual meeting, who had been admitted to membership subsequent to the 1964 meeting in Cody.

Frank J. Trelease, Dean of the Wyoming Law School, reported on the 1964-65 school year and the faculty plans for the 1965-66 year. Dean Trelease also reported on the National Defender Program on behalf of Professor Glen Shellhaas, who was unable to be in attendance at the meeting.
