## PRESIDENT'S PAGE

This is my first contribution to our legal publication since I became President of the State Bar last September. The Bar Officers and Commissioners met in Cheyenne on January 12th and on the next day met with the general membership for our biennial legislative meeting. We were all primarily concerned with the passage of Constitutional Amendment No. 1 and with the adoption of adequate legislation to implement that passage by the Legislature. As it turned out, the Legislature did appropriate \$10,000.00 to cover the study of plans to reorganize Wyoming's minor courts. I am planning to have the Minor Courts Committee work closely with the Statute Revision Commission so that we may come up with something solid and substantial by way of minor court reorganization for the 1969 Legislature.

The Laramie County Bar Association made the arrangements for the dinner-dance at the Plains Hotel on the night of January 13th and this was a most pleasant and successful event.

### *Bar Commissioners Elections*

Please remember that those Judicial Districts with odd numbers should hold District meetings within at least thirty days of the annual meeting for the purpose of electing new Bar Commissioners. Joe Maier of Torrington, David Burns of Jackson and Chester Ingle, Jr., of Thermopolis will all be completing two-year terms as Commissioners. It will be their responsibility to see that proper elections are called and held so that their successors may be named sufficiently in advance of the annual meeting in Cheyenne to be of use to the incoming President, Henry A. Burgess of Sheridan.

### *Annual Meeting, Cheyenne, Sept. 20-23, 1967*

The 52nd annual meeting of the Wyoming State Bar will be held in Cheyenne September 20th through the 23rd. Mrs. Brooke Wunnicke, President of the Laramie County Bar Association, has already appointed her committees in

Earl Morris, who will then be President of the American Bar Association following the Honolulu meeting, and Mrs. Morris will be present.
